2. Entry to the Promotion constitutes acceptance of these Terms and Conditions.
3. All entry instructions and prize information published by the Promoter form part of these Terms and Conditions.
4. The Promotion is open to all Australian residents aged 18 years who are a Trade Account holder with ACD Trade in Queensland, Northern Territory, Western Australia or New South Wales. Wholesale customers of the Promoter as well as employees of the Promoter and their immediate family are not eligible to enter the Promotion.
5. The Promotion commences Monday 7 October 2024 and Saturday 30 November 2024.
6. The Promotion is a game of chance.
